- The stock option vests and becomes exercisable as to 25% of the total shares on 10/15/19, and further vests in equal quarterly installments thereafter, with 100% of the total shares subject to the option vested on 10/15/22, subject to the Reporting Person's provision of service to the issuer on each vesting date.
